## About This Guide

This guide provides information on the QNAP TL-R400S and TL-R1200S-RP JBOD enclosures and step-by-step instructions on installing the hardware. It also provides instructions on basic operations and troubleshooting information.

### About QNAP JBOD Enclosures


QNAP JBOD enclosures are designed to increase the capacity and utility of your NAS or computer and provide a wide range of storage applications. Drives installed in JBOD enclosures can be managed independently or be configured as software RAID by the host device. The TL-R400S and TL-R1200S-RP feature SFF-8088 SATA 6 Gb/s ports to ensure quick and efficient data transfer between the JBOD enclosure and the host device.

### 3. Hardware Installation

This section provides information on installing drives and connecting the JBOD enclosure to a NAS or computer.

#### Drive Installation

QNAP JBOD enclosures are compatible with 3.5-inch and 2.5-inch hard drives and 2.5-inch solid-state drives.

#### Installing 3.5-inch Drives on 3.5-inch Trays

## Installing Handles

Installing handles enables you to better grip and secure the TL-R400S JBOD enclosure.

1. Power off the JBOD enclosure.
2. Install a handle on an angle bracket.
  - a. Align the openings on the handle with the two round screw holes on the angle bracket.
  - b. Attach the screws to lock the handle to the angle bracket.



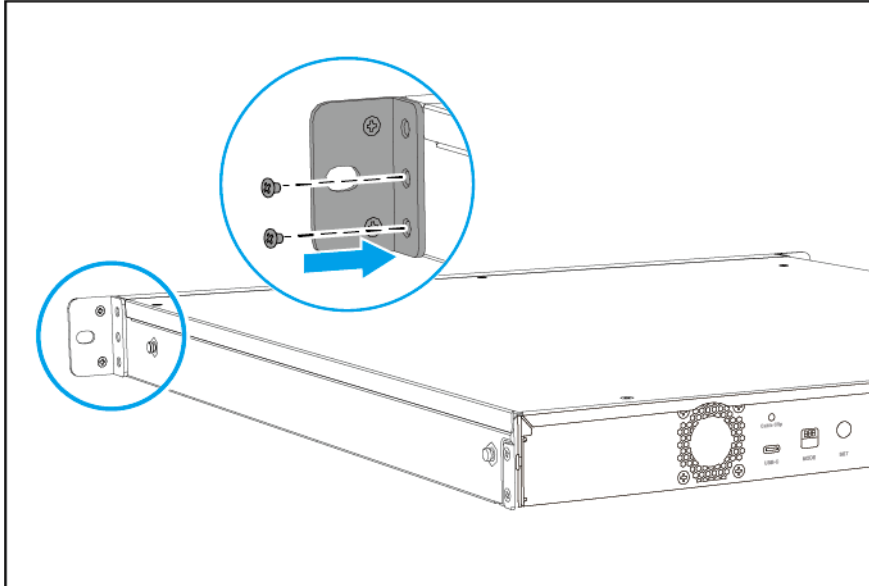
3. Install the angle bracket on the JBOD enclosure.

- a. Align the holes on the angle bracket with the holes on the chassis.


**Note**

Ensure that the handle faces the same direction as the front panel.

- b. Attach the screws.



4. Install a second handle on the other side of the chassis.
5. Power on the JBOD enclosure.

## Connecting the JBOD Enclosure to a NAS


**Important**

QTS can support a maximum of two JBOD enclosures.  
The NAS must run QTS hero or QTS 4.4.2 (or later versions).

1. Power off the NAS.
2. Power off the JBOD enclosure.
3. Connect the JBOD enclosure to the NAS.
  - a. Connect one or more SFF-8088 connector cables to the SFF-8088 ports on the JBOD enclosure.
  - b. Connect one or more SFF-8088 connector cables to the SFF-8088 or SFF-8644 ports on the host bus adapter installed in the NAS.

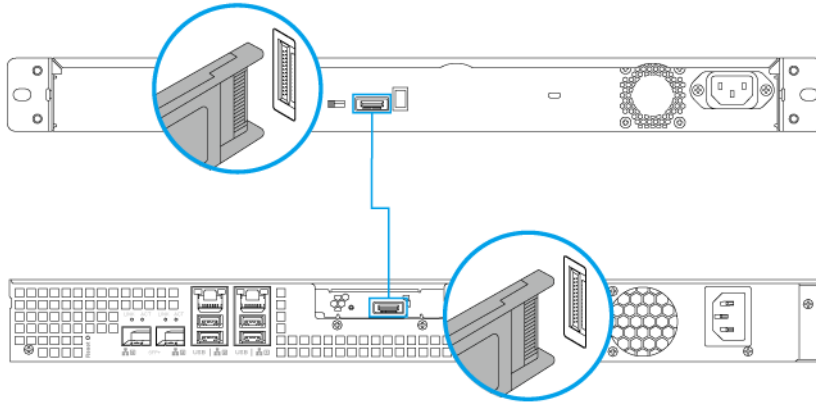

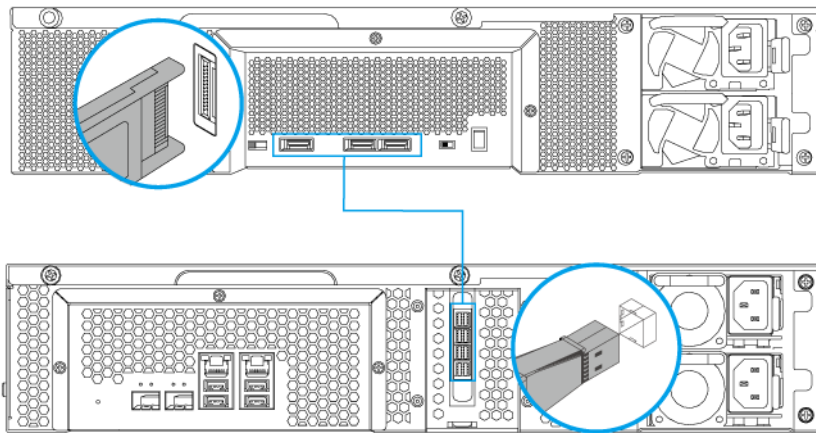

- c. Verify that the JBOD enclosures are listed.

Connecting the JBOD Enclosure to a Server

A Windows or Linux server does not limit the number of JBOD enclosures it can support.

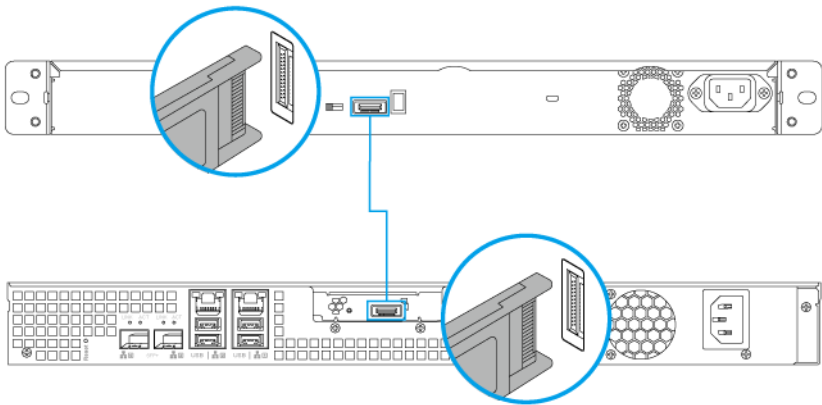
- 1. Power off the server.
- 2. Power off the JBOD enclosure.
- 3. Connect the JBOD enclosure to a server.
  - a. Connect one or more SFF-8088 connector cables to the SFF-8088 ports on the JBOD enclosure.
  - b. Connect one or more SFF-8088 connector cables to the SFF-8088 or SFF-8644 ports on the host bus adapter installed in the NAS.



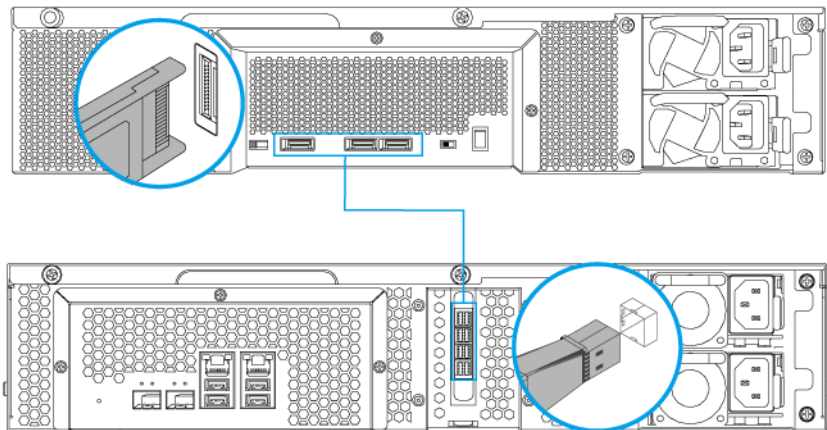

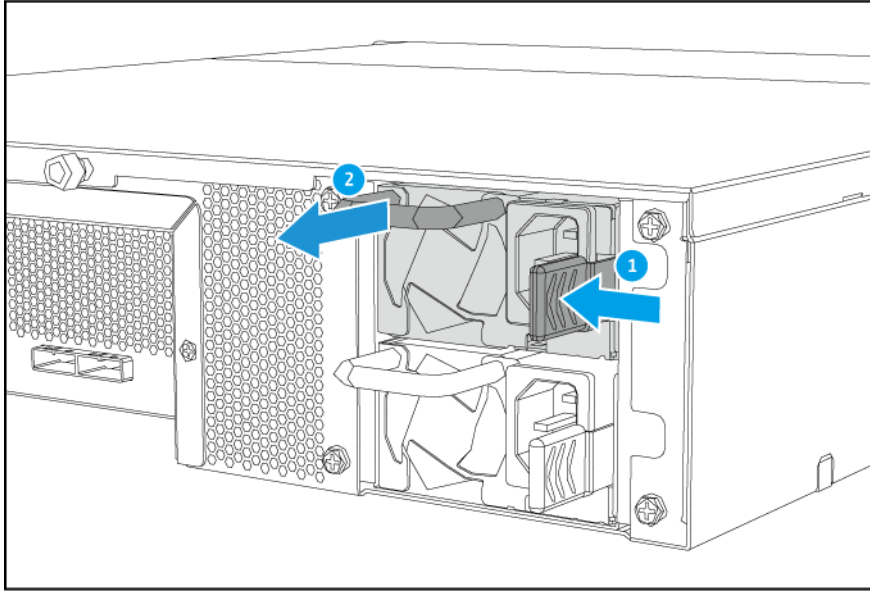

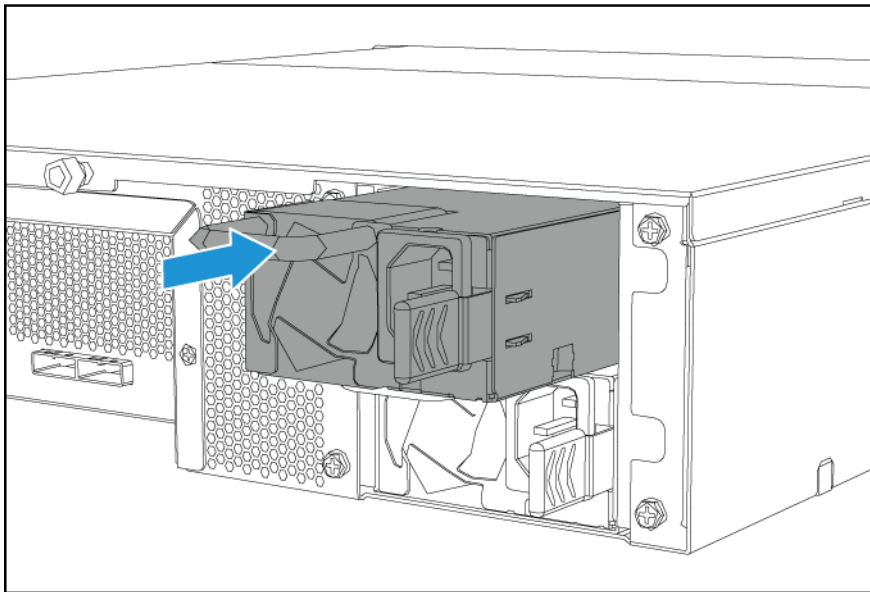

- 1. Disconnect the power cord from the electrical outlet and the PSU that you are replacing.
- 2. Firmly press the latch toward the handle and then pull the PSU out.





**3. Insert the new PSU.**



**4. Connect the power cord to the PSU and the electrical outlet.**

**5. Enable alerts for PSU failures.**

- a. Log on to QTS as administrator.
- b. Go to **Control Panel > System > Hardware > General**.
- c. Select **Enable Redundant Power Supply Mode**.
- d. Click **Apply All**.

## Rail Kits

The TL-R400S and TL-R1200S-RP are compatible with the following model:

- RAIL-B02

## 4. Basic Operations

This chapter describes basic operations of the JBOD enclosure.

### LEDs

LEDs indicate the system status and related information when the device is powered on. The following LED information applies only when the drive is correctly installed and when the device is connected to the network or to a host.

For details on the location of the LEDs, see [Front Panel](#).

LED	Status	Description
System Status	Green	The JBOD enclosure is ready.
	Red	<ul style="list-style-type: none"><li>• A system fan is not functioning.</li><li>• The system temperature is over 65°C.</li></ul>
Link	Green	The JBOD enclosure is connected to a host device.
	Off	The JBOD enclosure is not connected to a host device.
Fan	Red	A system fan is not functioning.
Drive	Green	<ul style="list-style-type: none"><li>• The JBOD enclosure is powered on.</li><li>• No JBOD expansion unit has been detected.</li></ul>
	Red	A drive read/write error occurred.




**Note**  
The drive LEDs only function when connected to a NAS or computer running QTS, QTS hero, or QNAP JBOD Manager.

Fan Speed Switch

The rear panel of the JBOD enclosure includes a fan speed switch for manually configuring the speed of the system fans.

When set, the fan speed changes automatically according to the internal temperature of the JBOD enclosure.
- High
- Medium
- Low

## 5. Troubleshooting

This chapter describes basic troubleshooting information.

### Forcing Storage & Snapshots or QNAP JBOD Manager to Recognize the JBOD Enclosure

If Storage & Snapshots or QNAP JBOD Manager is unable to locate the JBOD enclosure during operation, the drives or data may be faulty.

1. Power off the JBOD enclosure.
2. Remove all drives.
3. Power on the JBOD enclosure.
4. Locate the JBOD enclosure using Storage & Snapshots or QNAP JBOD Manager.
5. Reinsert the drives.
6. Continue with operation.

### Hot-swapping Failed Drives

The JBOD enclosure supports hot-swapping of drives in the following situations:

- RAID 1: One member drive fails
- RAID 5: One member drive fails
- RAID 10:
  - One member drive fails
  - Two member drives fail
- RAID 50: One member drive per disk subgroup fails
- RAID 60: Two member drives per disk subgroup fail

1. Log on to QTS.
2. Go to **Main Menu > Storage & Snapshots > Storage > External Storage**.
3. Locate the failed drive.
4. Prepare a new hard drive with a capacity that is the same as or larger than the failed hard drive.
5. Remove the failed drive from the JBOD enclosure.
6. Wait for 30 seconds or until the JBOD enclosure beeps twice.
7. Remove the failed drive from the drive tray.
8. Insert the new drive into the drive tray.
9. Install the new drive.  
The JBOD enclosure beeps twice.

- 10. Wait for 30 seconds or until the JBOD enclosure beeps twice.
- 11. Go to **Main Menu > Storage & Snapshots > Storage > Storage/Snapshots .**
- 12. Locate the volume that contains the new drive and then verify that the status is **Rebuilding**.
